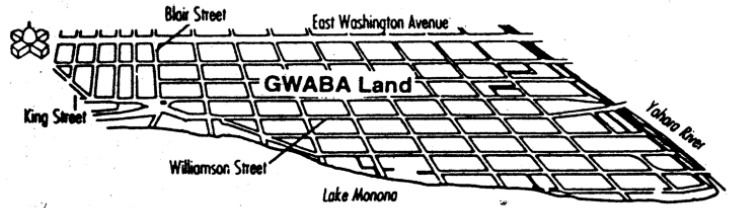

Article Three: Membership

1. **General:** The Association shall have two types of members: Regular and Associate.
 - a. Regular Members shall have the right to one vote on issues before the Association and may serve as Officers of the Association. This class of membership is open to any Business located or operating in the Community Area. Regular Members shall each have equal rights, duties, and privileges.
 - b. Associate Members shall not vote and shall not serve as an Officer of the Association. Associate Membership shall be open to (1) all Businesses, Organizations, and individuals who do not qualify for Regular Membership but who have an interest in furthering the objectives of the Association; and (2) Businesses and Organizations who qualify but do not wish to have voting rights.
2. **Eligibility:** Membership shall be open to all Businesses, Organizations, and individuals in the Community Area.
3. **Acceptance:** All eligible Businesses or Organizations that fill out a membership application form and pay the required fee, as set forth in these Bylaws, shall become a member upon acceptance of the application by the Officers of the Association. If an application for membership is rejected, the rejected applicant may appeal the decision to the membership of the Association, which shall decide by a majority vote.
4. **Termination:** The resignation or expulsion of a member or failure to pay Association dues shall result in termination of membership. Expulsion requires consensus by the Officers and, if accepted, allows for a refund of dues paid.
